A Healthy Legacy

A hard worker his entire life, William F. Thiel was dedicated to his family and to the community that he felt had been so good to him. Though he died almost forty years ago, through a gift to the Community Foundation his legacy is alive and well in Wyoming County where today he is credited with directly helping one-in-four community residents with their healthcare needs.

At his death, Mr. Thiel asked the Community Foundation to use his estate "to benefit the health needs of the residents of Wyoming County." Under the stewardship of the Foundation's investment committee, Mr. Thiel's fund grew over the years, and the amount it was able to grant toward efforts in Wyoming County also increased. So much so, that the Community Foundation realized there was the opportunity for his legacy to make an even greater impact.

In 2006, the Foundation commissioned a comprehensive Wyoming County Health Needs Assessment (WCHNA), to identify strategic priorities that required attention in order to realize Mr. Thiel's goals for improving health outcomes for Wyoming County residents.

"What we've done to honor Mr. Thiel's charitable wishes is a great example of how a community foundation can go above and beyond to fulfill a donor's legacy," said Clotilde Perez-Bode Dedecker, President and CEO of the Community Foundation. "With our knowledge of community needs, history of strong investment performance and unparalleled focus on honoring our donors' intent, we are able to grow a donor's charitable dollars so that they have the greatest possible impact on the issues

they care about today and long after we're all gone."

With the WCHNA as a guide, the Foundation has been supporting programs and facilitating the creation of new services in Mr. Thiel's name for the past five years. In just that short amount of time, his generosity has directly helped 25% of all Wyoming County residents with their healthcare needs. And, because he asked the Foundation to shepherd and grow his gift so that it is able to help his beloved community forever, this is just the beginning.

\$4 Million Raised for Green & Healthy Homes Initiative

During the past fourteen months, the Community Foundation has helped attract more than \$4 million in grants from New York State and the Federal Government to address home health and safety needs in Western New York. After leading the effort to name Buffalo as one of only 15 Green and Healthy Homes Initiative pilot communities in the country by the White House in 2010, the Foundation wasted no time in bringing public, private and nonprofit organizations together to create a coordinated system which reduces the energy costs and housing-related health hazards for low-income families.

In May 2011, the Foundation convened a summit and

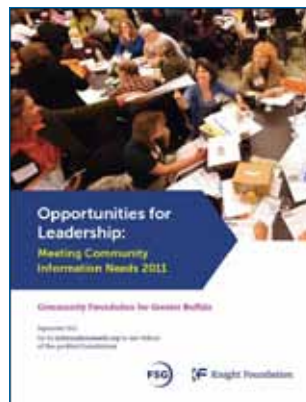

Cultures of Giving Legacy Initiative Leaders are Guests at Kellogg Foundation Summit

In 2010, Metropolitan Opera soprano, Angela Brown, came to Buffalo to do a fundraiser for the group and a generous anonymous donor gifted a \$50,000 matching grant for their work. In 2011, the great work continued with the W.K. Kellogg Foundation inviting the group’s leaders to speak at a philanthropy summit to share how they created the CGLI as a vehicle to unite communities of color to support youth. Q&A

with Patricia A. George Attorney at Law



Patricia A. George is an attorney based in Lockport, NY. She is a member of the Niagara Area Foundation (NAF) Council, the arm of the Community Foundation that focuses on the needs of Niagara County. Pat recently sat down with us to share her thoughts on the importance and value of a community foundation's options for donors who want to leave a legacy.

How did you first find out about the Community Foundation?

I was looking into options for a client who wanted to leave a charitable legacy in Niagara County. A colleague introduced me to the Community Foundation and it was a perfect fit. After I found out more, I realized this organization could be a great avenue for many of my clients, and I became a member of the Niagara Area Foundation (NAF) Council—the arm of the Community Foundation that focuses on the needs of Niagara County.

Under what circumstances do you discuss the Foundation with a client?

Whenever I meet with a client about estate planning, I ask if they have any interest in using their estate to provide support for charitable organizations or causes. Often, the answer is yes, and they want to give to multiple organizations or they don't have a specific organization in mind—more of an area of interest. This is when I introduce the options a community foundation can

provide. We talk about the purpose, mission and history of the Foundation and how it provides a permanent vehicle for honoring their charitable wishes and can support the issues and organizations that they care about, in their name, forever.

Please share a story of how a client of yours worked with the Foundation on their giving.

I work with a couple who initially came to me to establish their wills. They have no children, and wanted to arrange to leave their estates to benefit local charitable organizations. I provided information about how a community foundation could help them do this; first, by sharing information to help them learn more about which organizations are doing things in the community on the issues that they really cared about; and second, by inviting them to participate in a grant review meeting so they could see first-hand the types of projects that are seeking funding and pick the ones that resonated with their personal interests. I know they found this process

very rewarding. And, it's given them great confidence that after their lifetimes, the Foundation will continue to carry out their giving, in their names and as they've directed—forever.

What do your clients say about their experience with the Foundation?

It has been very positive. The staff is extremely helpful, and truly dedicated to finding opportunities that best match what each individual donor is interested in supporting.

Lately, I'm also hearing a lot about the investment returns that the Foundation is getting for its donors and how through them they are helping to increase the charitable resources that donors have at their disposal.

What role do you think a community foundation should play in the community at large?

People should be able to leave their money where they want to leave it. Often they've worked hard their entire lives for that money and I think it's important that they have dependable options for doing what they want with it and trust that after their lifetimes their wishes will continue to be carried out. The Community Foundation fills this niche nicely. It gives people the ability to leave a charitable legacy that will support what matters to them, forever.

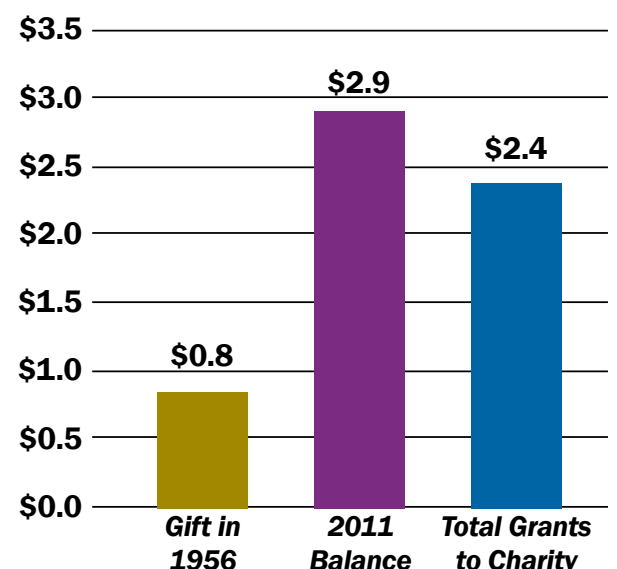

Snapshot: The Power of Endowment

In 1956, a former Buffalo resident established a fund in memory of her son who spent his short life in our community. Her original gift of \$800,000 was directed to support the changing needs of the community, in his name, forever.

Over the past 50 years, this fund has grown nearly 300% to \$2.9 million, and has granted \$2.4 million to organizations in the community to improve education, the environment and the arts.

stock as well as high poverty and unemployment rates, many children and their families are forced to live in homes that are unhealthy, unsafe and not energy efficient.

These factors can contribute to serious problems such as frequent visits to the emergency room for uncontrolled asthma due to mold exposure; poor academic performance due to brain damage from lead poisoning; and increased poverty due to high heating bills.

Despite the fact that these issues are all related to housing, the current method for addressing them relies on disparate programs with little or no coordination.

Buffalo's Green and Healthy Homes Initiative aligns and coordinates public and private funding sources and programs for weatherization, lead hazard control, asthma control, and other home health and safety interventions in low income homes.

Homes treated through this model:

- Consume less water and energy
- Produce less waste
- Do not contain health or safety threats.
- Maximize the benefits of individual home improvements
- Support the well-being of the people living there in many ways

brought together more than 60 public, nonprofit and private organizations to determine a plan of action for working together to help children and families living in subpar housing. As a result, partners like the City of Buffalo, Erie County, the Matt Urban Center, National Fuel and others have begun coordinating their services to more efficiently help families in need. The services they provide range from weatherization and insulation of windows and doors to reduce energy usage, removal of asthma triggers like mold, elimination of lead paint hazards, and exterior home

improvements like new roofs.

This highly collaborative effort has attracted significant attention from around the country, with the Community Foundation and its partners being highlighted by the Department of Housing and Urban Development as a national model for success and Foundation leadership are consistently asked to speak on our best practices in implementation.

Why It Matters

In communities like Buffalo that struggle with an aging and deteriorating housing

Green Jobs Program Provides Training and Employment

Using the Green and Healthy Homes model to connect service providers and braiding resources, the Community Foundation and partners at the Matt Urban Center and Erie County created a new program this year to provide green jobs training to adults currently receiving public assistance.

The program is one of the first in the

nation that weaves public and private funds to train welfare-to-work program participants to make them eligible for jobs in lead hazard control, environmental contracting and green demolition.

“This program is a great example of what can be accomplished when public and private entities come together to invest in our community,” said Marlies A. Wesolowski, Executive Director, Lt. Col. Matt Urban Human Services Center. “The results speak for themselves—with this specialized training the program participants are in a stronger position to find meaningful employment and through the course of their training they have directly improved the health and safety of homes in some of our most distressed neighborhoods.”

As part of the program, participants received on-site skills training by assisting in removing lead hazards from 62 homes in zip codes 14215 and 14217. Several of the homes where the work was done had previously been cited by the Health Department for lead paint hazards, but the homeowners were unable to do the work themselves.

While there are numerous job training programs in the City of Buffalo, none have lead hazard control as the primary focus.

“Given the deteriorated condition of much of the city's housing stock, current economic conditions and the prevalence of high unemployment, this initiative is critical to creating jobs and a sustainable workforce to address lead poisoning prevention through hazard reduction,” added Wesolowski.

According to graduate Tahwana Roberson, “I'm grateful for the opportunity to be in this program. I feel like we made a difference in the community and it gave me a real sense of accomplishment.”

Making the Case for Investing in Western New York






When it comes to creating change in our community on the most critical issues facing Western New Yorkers, we know no single entity can do it alone. With this in mind, and to build on the generosity of our donors, the Community Foundation seeks support from State, national and Federal funders, like the John S. and James L. Knight Foundation and the U.S. Department of Housing and Urban Development.

Funders are attracted to our region because they see opportunities to make meaningful investments, as well as our increasing ability to work collaboratively. The Community Foundation is honored to facilitate these efforts which coordinate the work of organizations and government so as to maximize existing resources and increase our impact.

During the past three years, our efforts to recruit funding to address needs in WNY have paid off to the tune of almost \$23 million. As a result, for every one dollar a Community Foundation donor has given to support the arts, education, the environment and neighborhood revitalization we have raised an additional \$8.

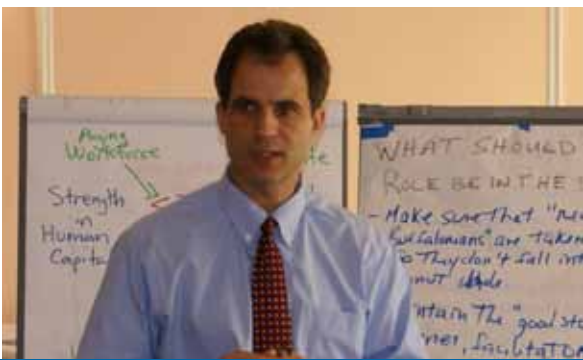
