

2026 Community Foundation for Greater Buffalo Competitive Process

Considering a Community Foundation Strategic Plan midterm update, the Community Foundation has revised its primary Competitive Process for 2026. Letters of intent have been eliminated. Instead, requests this year will be by full application only.

Please note, the Community Foundation for Greater Buffalo has only one annual Competitive Process grant cycle.

Deadlines:

- Application available online February 6, 2026
- Applications will be accepted until March 6, 2026 at 4 PM. No exceptions.
- Grant outcome notification will be sent to applicants in late June 2026

Applications must address one of the Solutions listed under the Community Foundation's four Community Goals. For 2026, applicants can submit for unrestricted support for programming.

I. Achieve racial/ethnic equity. Requests must address the following Solution:

1. Promote civic engagement and leadership

II. Promote economic mobility through educational achievement, workforce readiness and access to family sustaining jobs for residents living in low-income households. Requests must address one of the following Solutions:

1. Improve the school readiness of children (ages 5 and under), academic achievement and postsecondary completion of students living in low-income households.
2. Promote civic engagement and leadership

III. Steward significant environmental resources in the context of climate resilience.

For the purposes of this application, climate resilience is defined as: The ability to prepare for, recover from, and adapt to climate impacts. Resilience efforts must be executed at the asset, neighborhood, or individual level. Requests must address one of the following Solutions:

1. Protect and restore the region's waterways
2. Strengthen environmental organizations and collaboratives to support climate resilience and sustainability with a preference for addressing the needs of vulnerable communities and climate education
3. Promote civic engagement and leadership

IV. Promote regional vibrancy through architecture, arts, and culture. Requests must address one of the following Solutions:

Solutions

1. Promote equitable access to long-term arts instruction for children and youth living in low-income communities
2. Promote civic engagement and leadership

3. Promote cultural tourism by restoring and leveraging significant historic buildings and architectural landmarks. (Defining historic as official recognition by State/National Register of Historic Places or local preservation ordinance.)

NOTE: Special funding available to support the following:

- Programs that serve the visual, speech or hearing impaired (~\$10,000)
 - *Preference for this special funding will be given to applications that align with one of the Solutions listed under four Community Goals.*

With any of the above civic engagement and leadership Solutions, the Community Foundation is looking at the issue of civic health which is defined as: *Developing strong connections between residents, robust relationships between people and public institutions, and positive attachments to the places where they live.* **Civic engagement and leadership requests must directly and clearly connect to the Community Goal.**

Eligibility

- Grants are awarded only to organizations that have current Section 501(c)(3) status as determined by the Internal Revenue Service.
- Applicants must be located in or serving one of the eight counties of Western New York: Allegany, Cattaraugus, Chautauqua, Erie, Genesee, Niagara, Orleans, and Wyoming.

Other Matters

- Submitted applications will receive an emailed acknowledgement sent to the account used to log into the system. This is your proof of submission.
- Any one organization may submit up to two applications maximum. However, each organization can only receive one grant through this process yearly and, should funding be awarded, the choice of what is funded is at the discretion of the Community Foundation.
- If a non-profit received a 2025 Community Foundation competitive grant from this process, they will not be eligible to apply to the 2026 cycle.
- The Foundation will offer the opportunity for multi-year support with consecutive year support contingent upon prior year outcomes.
 - Multi-year grants will only be offered to those organizations with a past grant history with the Community Foundation and based on the request.
 - Please contact Director, Community Impact Darren Penoyer to discuss multi-year requests *before* applying.
- The Foundation expects that all grants be utilized within one year of receipt of funds, except for multi-year awards.
- The Foundation is receptive to requests that address advocacy, research and policy analysis aligned with the four Community Goals.
- The Foundation reserves the right to pay grants in a single installment or in “draws” at its sole discretion.
- Applications may be shared with Foundation clients.
- The use of grant funds for purposes not pre-approved by the Foundation or not supported through required documentation will result in a request that those grant funds be returned to the Foundation.
- The Foundation will **not** consider competitive funding for:
 - Higher education scholarships (separate application, deadlines, and process)
 - Projects outside the eight Western New York counties (Allegany, Cattaraugus, Chautauqua, Erie, Genesee, Niagara, Orleans and Wyoming)
 - Religious purposes. Funding cannot be used to support religious activities such as worship or proselytizing. Secular programs or services must be available to eligible participants without regard to religious belief or willingness to participate in religious activities.
 - Schools not registered with the New York State Education Department
 - Attendance at or sponsorship of fundraising events for organizations

- Field trips, museum, cultural, and event admissions/tickets, and school assemblies unless they are part of a long-term program or curriculum
- Annual events or festivals
- Any partisan political activity. Funds from the foundation cannot be used to support or oppose a candidate for political office.
- Projects and activities that have occurred. The Foundation will not, except in extraordinary cases, provide payment or reimbursement for expenses incurred prior to the funding decision being communicated to the applicant.

Funding amounts

- The average grant through this process over the past decade is \$18,000 TO \$20,000. The maximum award is \$50,000.
